Notice to Employers/Insurers:

Attached is the requested wall card for your employer site.

When an employer has received notice of an on the job injury, the employer/insurer must provide the injured worker with a designated provider list from which an injured employee may select an attending physician.

- A.) The list must be in writing and must consist of at least:
 - 1.) Two physicians; **or**,
 - 2.) Two corporate medical providers; **or**,
 - 3.) One physician and one corporate medical provider.
- B.) The two designated providers on the list must be at two distinct locations without common ownership.
 - 1.) If there are not two providers at two distinct locations without common ownership within thirty miles of each other, then an employer may designate two providers at the same location or with shared ownership interests.
- C.) The list must state the following information:
 - 1.) The insurer responsible for the claim, or that the employer is self-insured; and,
 - 2.) The address where the provider can submit bills; and,
 - 3.) The name and contact information of up to two insurer's/employer's representatives.

The designated provider list can initially be provided to the injured worker verbally or through a pre-injury designation, such as the attached worksite poster. However, even if the list is provided as described above, a written designated provider list must be mailed, hand-delivered, or furnished in some other verifiable manner to the injured worker within seven (7) business days following the date the employer has notice of the injury. If the employer fails to comply with the above requirements, the injured worker may select an authorized treating physician of his or her choosing. Please be advised the required information above can be added to the attached listing and together that would meet the requirements of the designated provider list.

NOTICE TO ALL EMPLOYEES

If you become injured on the job...

Take the following steps:

- Notify a member of Management of your injury immediately.
- If you feel that you need medical attention, the providers listed are available for treatment.
- Please call the provider to schedule an appointment.
- For urgent care needs OR after clinic hours, you may seek treatment from the hospital Emergency Department listed OR the nearest qualified facility or provider.
- Patients will be seen on a medical priority basis.
- Please advise the provider to contact your employer for information on where to submit billing information.
