An injury by occupational disease is compensable only if the occupational exposure was the prevailing factor in causing both the resulting medical condition and disability. | Workers'<br>Compensation<br>Benefits Include | In addition to all other compensation paid to the employee under §287.140 RSMo, the employee is entitled to receive: <ul> <li>Medical Care</li> <li>The employer shall provide medical care as may reasonably be required after the injury or disability to cure and relieve the employee from the effects of the injury. Medical treatment is without a deductible to the employee or dollar limit. Costs are paid directly by your employer's insurance company, so you should not receive a bill. If you do receive a bill, give it to the employer's designated representative or contact the insurer listed below.</li> </ul> Your employer will arrange for medical treatment and select a doctor to care for your workers' compensation injury. If you go to another doctor without prior authorization from the employer. If you go to another doctor without prior authorization, it is at your expense. Payment for Lost Wages. If you are unable to return to any form of employment due to the injury or illness, you should receive temporary total disability (ITD) benefits that are tax-free, until the treating doctor says you are able to return to work. Payments are two-thirds of your average weekly wage, up to a maximum rate set by state law. Payments are not made for the first three days or less that your employer is open for business, unless you are unable to work more than 14 calendar days. If you do not receive a check, contact the insurer listed below. An employee is disqualified from receiving TTD during any period of time that the employee applies and receives unemployment compensation. Permanent Disability Benefits If the injury or illness results in a permanent disability you may be entitled to receive either permanent partial or permanent total disability benefits. |
